PURPOSE

To establish an official uniform policy. This is a list of items approved by the District to be worn on-duty or on an incident but is not a list of items each employee will be issued. See MOU for list of items issued by the District to full-time staff. All other staff members will be issued uniforms and PPE based on need and approval of the fire chief.

SCOPE

Safety Personnel

POLICY/GUIDELINE

- 1. Uniform Care & Standards of Conduct
 - a. Changing uniforms shall be conducted in the privacy of the dorm room, appropriate restroom, or locker room.
 - b. Captains shall determine modification to the uniform-of-the-day based on tasks being performed during each shift.
 - C. Duty uniforms shall be provided to all employees according to the current Administrative Manual, SOG manual, and/or MOU.
 - d. Uniforms shall be maintained in good condition. Uniforms that are stained, torn, worn, faded, too small or too large shall be removed from service.
 - e. Uniforms may be declared out-of-service by any officer and replaced by the district when the condition of the garment does not meet the intent of this guideline.
 - f. Employees may utilize the BBFPD domestic washing machine and dryer to help maintain uniforms.
 - g. Department approved hats may be worn during non-emergency/EMS work activities not requiring safety helmets.
 - h. BBFPD uniforms are the property of the fire district and shall be worn in the course of performing BBFPD business and only by employees of the district.
 - Employees shall contact the employee in charge of PPE/Uniforms (currently FF/P Jim Levy) for uniform needs.
 - j. Each firefighter will be responsible for this gear and to keep it clean and serviceable at all times.
 - k. Keep all gear out of the sun, as the sun can deteriorate some materials.
 - I. Hazardous materials and some fires conditions can contaminate turnout gear and make them dangerous to wear if not properly cleaned and decontaminated. See the manufacture guidelines for additional information for proper cleaning.

- 1. Recommended manufacture: Jerzees
- 2. Navy blue color
- 3. Shall have a 1/4 zip neck
- 4. Shall have "Bodega Bay" (white letters) above the 88 Maltese cross on left breast
- 5. Shall have the Name and Rank (white letters) on the right breast

UNIFORM DUTY SHIRT-POLO ATERNATE

- 1. Recommended manufacturer: Cornerstone
- 2. Navy Blue in color
- 3. Shall have "Bodega Bay" (white letters) above the 88 Maltese cross on left breast
- 4. Shall have the Name and Rank (white letters) on the right breast

UNIFORM DUTY SHIRT

- 1. Recommended manufacture: Flying Cross or Workrite-Straight Yoke
- 2. Midnight Navy blue in color. Shall be made of Nomex material
- 3. Button up front. Actual closure may be button down or snap
- 4. Two front pockets with button or Velcro closure
- 5. Sewn badge placement area
- 6. Pen area in left pocket
- 7. Shall have the BBFPD patch sewn on both shoulders

UNIFORM DUTY PANTS

- 1. Recommended manufacture: Flying Cross, Workrite or Cascade
- 2. Meet NFPA 1975 standard for station or work uniforms
- 3. Midnight Navy blue in color. Shall be made of Nomex material
- 4. Two front and two rear pockets
- 5. Pockets on legs are optional

UNIFORM T-SHIRT

- 1. To be short or long sleeve
- 2. Shall be navy blue in color
- 3. Shall identify the District on front and back in white letters
- 4. Issued by the District

BASEBALL STYLE HAT

- 1. Navy in color
- 2. Issued by the District
- 3. Rear name identification is optional and at employee cost

BOONIES/ BEANIES

- 1. Navy in Color
- 2. Issued by the District

DUTY BOOTS

- 1. Recommended manufacture: Danner or Haix
- 2. Black in color

- 4. To be pin and clutch back attachment.
- 5. Each nametag must have first and last name plus fire or EMS rank.
- 6. Name tag to be attached centered ½ inch above the right front pocket seam

- Shall be approved by NFPA 1971 Standard on Protective Ensembles for Structural Fire Fighting and Proximity Fire Fighting

WILDAND FIRE PPE

Wildland firefighting PPE should include the following listed items and in addition should include approved web gear with an attached fire shelter anytime a member is actively involved on a wildland incident.

WILDLAND FIRE SUPPRESSION JACKET

- 1. Recommended manufacturer: Cascade or Sonoma County Spec.
- Shall be approved by NFPA 1977 Standard on Protective Clothing and Equipment for Wildland Fire Fighting
- 3. Shall be yellow Nomex material or other fire resistive material.
- 4. The District shall be identified in block letters matching the reflective material on the upper back area. 4 inch letters shall be used stating "BODEGA BAY"

WILDLAND FIRE SUPPRESSION PANTS

- 1. Recommended manufacturer: Cascade or Sonoma County Spec.
- 2. Shall be approved by NFPA 1977 Standard on Protective Clothing and Equipment for Wildland Fire Fighting.
- 3. Dual compliant Cascade pants may be worn as single layer.
- 4. Shall be Nomex material or other fire resistive material.

WILDLAND FIRE SUPPRESSION BOOTS

- 1. Recommended manufacturer: Wesco or Danner.
- 2. Shall meet the standard CCR 3410. And NFPA 1977 Standard on Protective Clothing and Equipment for Wildland Fire Fighting
- Shall be a heavy-duty lace-up type work boot with non-slip approved soles and heels, and shall provide firm ankle support. Leather tops shall be at least 8 inches in height measured from the bottom of the shoe heel.
